

FOR ALL PUBLIC EVENTS THAT INVOLVE FILMING AND/OR EPISODIC RELEASE ON OUR SOCIAL MEDIA, HERE ARE THE ELIGIBILITY REQUIREMENTS AND ACKNOWLEDGEMENT. LAST UPDATED ON SEPTEMBER 25, 2020.

ELIGIBILITY REQUIREMENTS

- 1. You must be 18 and older to participate in The Amazing Hunt (the "Competition").
- 2. You are allowed to bring a limited number of items permitted by the Producer (excluding, among other things, certain items, to be specified later) and may or may not have access to your belongings in the Competition.
- 3. You are not allowed to use any device, equipment and/or tools to record anything regarding any details of the Competition.
- 4. During the Competition, all travel expenses will be at your own expense and will not be compensated under any circumstance.
- 5. You must be in good physical and mental health and you must accept and assume all risks of injury, death, illness or disease, or other damage to yourself, to others, or to your and their property, which arise in any way from their participation in this Competition. You must understand your physical limitation and are sufficiently self-aware to stop physical activity before you become ill or injured.
- 6. By submitting this electronic version of The Amazing Hunt Release and Waiver (the "Form"), you agree to release, discharge and hold harmless the Producer and the production crew of The Amazing Hunt from all claims and damages arising out of your participation in the Competition itself.
- 7. You must abide by all applicable Canada laws during the Competition. In addition, you must agree to interact appropriately with the other participants and cooperate with the Producer during the Competition.
- 8. Upon the Producer's request, you must agree to sign and abide by the terms of any additional releases or authorizations that the Producer, in his sole discretion, deems necessary.
- 9. All Forms become the sole property of the Producer. The Producer owns, and is not obligated to return or maintain (and may destroy) any Forms. The Producer is not responsible for any lost, stolen, or incorrect Forms. All eligibility requirements and any content stated on the release and waiver in this Form is in effect, is enforced, and will be applied to you in any Competition that you choose and/or are chosen to participate in from the date you submitted the Form.
- 10. The Producer reserves the right to disqualify any participants for tampering, threatening or harming another person, violating the official rules, or other rules then in effect or the standards and practices and policies of the Producer. If you face a disqualification, you agree to forfeit your payment and will not be compensated under any circumstances.
- 11. The Producer reserves the right to change, including, but not limited to, the location and/or time of the Competition. You as a participant of this Competition must be available and will not be excused for any reasons as long as you are still a part of this Competition.

ACKNOWLEDGEMENT

a. I acknowledge that: (i) I have read, understand, am satisfied and agree to be bound by the eligibility requirements set forth in this electronic version of The Amazing Hunt's Release and Waiver; (ii) I will answer the questions in The Amazing Hunt's Release and Waiver honestly, accurately and completely; (iii) if any of the information I submit is found to be false or incomplete, this will be grounds for dismissal from the participant selection process and/or from the Competition, and may also result in the forfeiture of any prizes or other items I may be awarded (whether or not I have already received them); (iv) my voice, action, and

likeness may be recorded as a part of this participant selection process and I understand that Producer may, but is in no way obligated to, use such recordings within the Competition and all related productions and publicity or in any other manner at the discretion of Producer; (v) even if I am selected as a participant, Producer has no obligation to produce or conduct the Competition and has no obligation to exhibit it, even if conducted and produced; and (vi) all decisions by Producer concerning selection of the participants are final and not subject to challenge appeal.

- b. All decisions regarding the Competition, including but not limited to, rules, eligibility, participants selection, event production, gameplay, tasks, elimination and award of prizes, are at the Producer's sole and exclusive discretion, are final, and are not subject to appeal. I understand and agree that all participant selection, gameplay progress and elimination decisions shall be final and binding on me in all respects, and shall not be subject to challenge or appeal. I acknowledge and agree that any information or personal sensitive data including but not limited to provided by me or obtained by Producer may be used for the purpose of making casting and other similar decisions for the production (and public viewing) of the Competition, and, with the exception of medical information, may be described, disclosed or otherwise used in and in connection with the Competition, any subsequent seasons of the Competition, and any ancillary or related productions, including "making-of" and "behind-the-scenes" productions, and/or for publicity and promotional purposes related thereto.
- d. I acknowledge that in the event I breach the confidentiality or any other provisions of this release and waiver or my participation in the Competition, my breach may, in the sole discretion of Producer, result in my being disqualified to participate as a participant in the Competition. I further acknowledge that a breach by me of any of the confidentiality provisions of this Competition or my participation in the Competition would cause Producer irreparable injury and damage that cannot be reasonably or adequately compensated by damages in an action at law, and, therefore, I hereby expressly agree that Producer shall be entitled to injunctive and other equitable relief to prevent and/or cure any breach or threatened breach of any of the confidentiality provisions by me. I also here by agree to let The Amazing Hunt pursue legal actions if any of my doing may have caused any damages to the production, the production crew and the reputation of The Amazing Hunt hereafter the submission of the Form and my participation in the Competition.
- e. I hereby consent to the production, reproduction, broadcast, publication, exhibition, distribution, adaptation, recording, use and reuse by Producer in any or all media now known or hereafter devised in or in connection with the potential reality-based television series (collectively, the "Releasees") of my voice, language, actions, manner, likeness, name, appearance, biographical material, still pictures, videos and any information (collectively, the "Likeness") contained or derived from my submission of the Form, precompetition video interviews, and my participation in the Competition, as such Likeness may be edited, altered, or modified by Releasees, in any and all media now known or hereafter devised, in or in connection with the Competition and all related productions such as, publicity material, spin-offs or advertising. The scope of the related productions will be limited to the Competition experience, personal portfolios and demonstration of skill sets by Producer and the production crew of The Amazing Hunt. Intending to be legally bound, I do hereby, for myself, and my heirs, executors, administrators, and any affiliated associations, waiver, release and forever discharge any and all rights or claims for damages and contractual violations which may have or which hereafter accrue to me against all persons, or organizations, and legal entitles affiliated with The Amazing Hunt, and more particularly to Producer and the production crew of The Amazing Hunt, individually, and a whole, for any and all damages and any contractual violations which may be sustained or suffered by me in conjunction with my entry in, and/or arising out of my travel to participation in, or returning from the Competition.
